ELECTRONIC SUBMISSION OF BUILDING PLANS & DOCUMENTS FOR REGULATORY APPROVAL

In our circular dated 30 Aug 02, we stated that with effect from **1 Jan 03**, the following projects/applications will be required to be submitted via eSS (electronic submission system) for regulatory approval:

- (a) Any project that has been submitted and approved through URA's EDA system after 1 Jan 03;
- (b) All statutory boards' projects;
- (c) All applications for permit to carry out building works; and
- (d) All applications for Temporary Occupation Permit (TOP)/ Certificate of Statutory Completion (CSC) and bookings for site inspection under the Advance Booking System (ABS).

2. Following feedback from the industry, the application procedures to obtain permit to commence work and permit to erect temporary building works have been revised. With effect from 1 Jan 03, Qualified Persons shall follow the revised procedures as in Annex A to submit applications for permit to carry out building works.
