CIRCULAR TO PROFESSIONAL INSTITUTES

SS CP 530 CODE OF PRACTICE FOR ENERGY EFFICIENCY STANDARD FOR BUILDING SERVICES AND EQUIPMENT

Objective

1 This circular is to inform the building industry that SS CP 24 referred to in the Approved Document Section I shall be superseded by SS CP 530.

Effective date

In the Approved Document, SS CP 530 shall replace SS CP 24 with immediate effect. However, for projects with building plans submitted to the Building and Construction Authority (BCA) for approval before **1 July 2007**, the qualified persons (QPs) may continue to follow SS CP 24.

Background

- The title of SS CP 530 is Code of Practice for Energy Efficiency Standard for Building Services and Equipment. SS CP 24 shares the same title.
- 4 SPRING Singapore has announced on 12 Feb 2007 that CP 24 has been revised and re-numbered as SS CP 530. The revision includes changes made to align the energy efficiency requirements with the international standards.
- 5 Section I, Energy Efficiency, in the Approved Document has stipulation referring to SS CP 24 currently. The reference will be superseded according to paragraph 2 of this circular.
