PUBLIC VIEWS SOUGHT ON REVISED BARRIER-FREE ACCESSIBILITY CODE

The Code Review Committee chaired by BCA was formed in November 2005 to review the Code on Barrier-Free Accessibility in Buildings 2002. The Committee comprising representatives from relevant government agencies, industry players and voluntary welfare organisations (see Annex A) aims to update the current Code to meet the needs of a larger group of users. Specifically, the objectives of the review are:

- a. To expand the scope from the barrier-free provisions for the buildings to the whole built environment.
- To incorporate new requirements for the purpose of improving accessibility at interfaces between buildings and from buildings to infrastructures.
- c. To provide elder-friendly features and other mandatory requirements for specific users.
- d. To update the current Code in response to feedback from the industry and to meet the need of users.
- The review was completed and the draft of the revised Code was open for public feedback with effect from 1 July 2007. The draft of this **Code on Accessibility in the Built Environment 2007** can be downloaded from BCA website www.bca.gov.sg.
- The Code Review Committee welcomes any feedback that you or your members may have on the draft Code. Such inputs would help the Committee to refine its recommendations before the revised Code is finalized for adoption.
