#### CBPU CIRCULAR (9/2000)

### AMENDMENTS TO FORMS:

- a. APPLICATION FOR CLEARANCE CERTIFICATE FOR DP ON SEWERAGE
- b. CERTIFICATE OF SUPERVISION AND INSPECTION FOR SANITARY/ SEWERAGE WORKS

We refer to our earlier Circular (8/2000) dated 4 Aug 2000 on the implementation of new standard application forms for application to CBPU for BP clearances and TOP/CSC clearances from 1 Oct 2000

- There was a recent incident of water contamination at Bukit Timah Plaza. Investigations into the incident revealed that leakage of wastewater from sanitary pipes which ran across potable water tanks had caused the contamination. Please note that such design of sanitary pipes running above potable water tank is not allowed under the Code of Practice on Sewerage and Sanitary Works (1st Edition-Mar 2000).
- 3 We have amended the Application Form for Clearance Certificate for DP on Sewerage and the Certificate of Supervision and Inspection for Sanitary/Sewerage Works (Form C/QP/SEW) by inserting a "there is no sanitary pipe located directly above any water tanks" in the standard endorsement of these forms. This is to remind QPs of the requirement not to construct sanitary pipes/floor traps over potable water tanks
