**CBPU CIRCULAR
REVISED CODE OF PRACTICE ON ENVIRONMENTAL HEALTH(COPEH) (2005
EDITION)**

The revised Code of Practice on Environmental Health (COPEH) (2005 edition) has replaced the COPEH (1998 edition) with effect from 19 Nov 2005. The revised COPEH (2005 edition) is available at our website address http://app.nea.gov.sg/cms/htdocs/category_sub.asp?cid=99.

2 A grace period would be given for QPs to adopt the revised COPEH (2005 edition) for the preparation of their building plans. As such, QPs may use the previous COPEH (1998 edition) for the preparation of their DC plans and BPs on EH up to 28 Feb 2006. QPs would need to inform CBPU in writing that their DC plans and BPs on EH are in accordance with the previous COPEH (1998 edition). QPs are, however, encouraged to use the revised COPEH (2005 edition) immediately.


3 With effect from 1 Mar 2006, all submissions for DC and BP on EH clearance shall comply with the EH requirements in the revised COPEH (2005 edition).
