DUCTILE IRON PIPES & FITTINGS – BS EN 545:2010 AND BS EN 598: 2007

We refer to our circular of 13 Aug 12 (our Reference: WSN 92413/90) and 8 Jul 13 (our Reference: WRN/SAN108) on the above mentioned matter.

- We wish to inform that after receiving feedback from the industry on the constraint to meet the deadline of 1 Sep 13 in complying with BS EN 545:2010 and BS EN 598:2007 for Cement-lined Ductile Iron pipes and fittings for potable water and used water use respectively, PUB had reviewed the request from industry and is pleased to inform that we will revise the implementation date of adopting BS EN 545:2010 and BS EN 598:2007 for all cement-lined ductile iron pipes and fittings meant for potable water and used water applications respectively to 1 Jan 14.
- Suppliers and installers shall ensure that the cement-lined Ductile Iron pipes/fittings comply with the above prescribed standards and supported with valid, complete and full test reports and certificates. Suppliers shall ensure that these test reports and certificates are properly kept and must be produced for verification upon request by PUB. PUB will conduct checks and take action against non-compliance. The responsible Professional Engineer/Architect and licensed plumber/contractor for the project shall use the correct pipes/fittings and they would be required to submit such certificates/test reports to PUB. Also, suppliers of Ductile Iron pipes/fittings shall ensure the proper marking of the respective Ductile Iron pipes/fittings, i.e. BS EN 545:2010 for potable water use and BS EN 598: 2007 for sewerage use.
