PERFORMANCE-BASED FIRE SAFETY REGULATORY SYSTEM

We are pleased to inform that the performance-based fire safety regulatory system will be implemented with effect from 1 July 2004 under the Fire Safety (Amendment) Act 2004. A performance-based approach to fire safety design can bring about added flexibility and innovation in the building design process while allowing for potential savings in building costs.

- 2. In a performance-based approach, there are many ways of designing fire protection measures to achieve the desired level of fire safety. Building designers use fire safety engineering principles and design tools such as fire and evacuation models to develop fire protection measures to achieve the desired fire safety objectives. These fire safety objectives and the conditions to fulfil them are spelt out in the performance-based provisions. Such an approach to fire safety design can only be undertaken by a fire safety engineer registered under the Fire Safety Act. The design would have to be reviewed by a peer reviewer, who is also a registered fire safety engineer. These provisions are given in Section 23 of the recently amended Fire Safety Act. Thereafter, the completed fire safety engineering works are to be inspected by a Registered Inspector who must also be a fire safety engineer, as stipulated under Regulation 4 of the Fire Safety (Registered Inspectors)(Amendment) Regulations 2004.
