# CENTRALISATION OF BUILDING CONTROL UNITS OF HDB/JTC/LTA: SUBMISSION OF FIRE SAFETY PLANS FOR REGULATORY APPROVAL AND APPLICATION FOR TEMPORARY FIRE PERMIT/FIRE SAFETY CERTIFICATE AND FIRE CERTIFICATE

Fire Safety & Shelter Department (FSSD) of SCDF will take over the fire safety functions currently performed by the Building Control Units (BCUs) of HDB, JTC and LTA with effect from 1 October 2005. Please be informed that from the date, all submissions of plans for fire safety works, applications for Temporary Fire Permit/ Fire Safety Certificate and applications for Fire Certificates under the Fire Safety Act will have to be submitted to FSSD instead.

- 2 Under Section 23 of Fire Safety Act, all new submissions, including HDB's, JTC's and LTA's projects, are to be accompanied by the required plan fees as prescribed in Part VI of the Fire Safety (Building Fire Safety) Regulations.
- 3 The Building & Construction Authority, together with FSSD, will be organising briefing sessions to the professionals, in mid Sept 05, on how to make submissions to the respective authorities through the CORENET.
