REVIEW OF OCCUPANT LOAD FACTOR FOR BOARDING HOUSE/BACKPACKER HOTEL/BUDGET HOTEL

The Fire Code stipulates the occupant load factor for hotel, boarding house and backpacker hotel as 4 persons per guestroom. However, the mode of occupation of these guestrooms varies with size of room and mode of operation of the business. The issue has been deliberated by the Fire Code Review Committee and the FSSD Standing Committee recently. The committees agreed that:

a. For hotel guestroom/hotel suites, the occupant load factor shall be based on 15 sqm/person. The occupant load shall be calculated based on the gross floor area of each room (i.e. include other areas such as living area, toilet, etc);

b. For backpacker hotel where a room is shared by hotel guests, the occupant load shall be based on 3 sqm per person, subject to a maximum of 20 person per room (i.e. maximum area of a backpacker room shall not exceed 60 sqm). The occupant load shall be calculated based on the gross floor area of the room (i.e. including other areas such as living area, toilet, etc); and

c. The occupant load of each room shall be calculated separately. The aggregate area of all the guestrooms shall not be used. For example, a floor with 30 hotel guestrooms of 32 sqm each, the occupant load for that floor shall be 90 persons (3 persons per room). One should not take the aggregate area of 960 sqm to get 64 persons.
