ELECTRONIC SUBMISSION OF BUILDING PLANS & DOCUMENTS FOR REGULATORY APPROVAL

In our earlier circular dated 21 Oct 03, we have announced a phased approach in implementing mandatory e-submission as shown below:

- (a) For all types of plans except those in (b) and (c) below - mandatory e-submission to take effect from 1 July 2004;
- (b) For structural plans and calculations - mandatory e-submission to start from 1 Jan 2005;
- (c) For Addition and Alteration (A&A) plans – mandatory e-submission postponed till further notice.

2 We wish to remind all Qualified Persons that, with effect from 1 July 2004, the mandatory e-submission requirements as stated in item (a) above shall apply to all submissions made to all the participating agencies in CORENET.
