## REVISED GUIDELINES FOR CERTIFICATION OF REGULATED FIRE SAFETY PRODUCTS/MATERIALS

SCDF received feedback from the industry that there are inconsistencies in the practice of certification standards for regulated fire safety products in Singapore by various Certification Bodies (CBs). As a result, SCDF has reviewed the current practice to enhance the transparency and effectiveness of the Product Listing Scheme (PLS).

2. With effect from 5 August 2013, any CB offering certification services to the industry in Singapore shall be accredited by Singapore Accreditation Council (SAC) for certifying regulated fire safety products/materials. All qualified CBs shall comply with the attached guidelines.
3. The list of regulated fire safety products/materials, its required test standards and surveillance regime are given in Annex A of the guidelines. It is also available at SCDF website at <http://www.scdf.gov.sg>.
