## RECOGNIZING SAFETY COURSES FOR UPGRADING UNDER THE MULTI-SKILLING SCHEME

This circular informs the industry on the extension of the Multi-skilling scheme for experienced construction personnel who are specialized in safety-related works on site.

- 2. The Building and Construction Authority (BCA) has worked with the Ministry of Manpower (MOM) and the Singapore Contractors Association Limited (SCAL) to introduce a new upgrading pathway under the Multi-skilling Scheme to recognize experienced construction personnel who are specialised in safety-related works as Higher Skilled (R1) workers. This is an extension of the existing Multi-skilling scheme which was launched in 2012 with the aim to build up a pool of workers who are competent in multiple construction trades to carry out more than one type of work tasks on site. Higher Skilled (R1) workers can enjoy a longer allowable Period of Employment (POE) of up to 22 years and lower foreign worker levies.
- 3. From 1 October 2016, Basic Skilled (R2) workers, who have an existing Skills Evaluation Certificate (Knowledge) or SEC(K) in the construction trade, can be certified as Higher Skilled (R1) workers under the Multi-skilling scheme if they meet the following criteria:
  - a) Have at least 6 years of construction experience in Singapore; and
  - b) Completed 120 hours of training in approved safety-related courses (see Annex A) OR obtained WSQ Advanced Certificate in Workplace Safety and Health.

Workers will be subject to the Continuing Education & Training (CET) requirement during the renewal of their Multi-skilling registration every 2 years.
