NEW PUBLIC UTILITIES (PROTECTION OF WATER PIPES INFRASTRUCTURE) REGULATIONS AND SEWERAGE AND DRAINAGE (PROTECTION OF PUBLIC SEWERAGE SYSTEM) REGULATIONS

We refer to our earlier circular dated 31 Jan 17 informing on two new Regulations i.e. the Public Utilities (Protection of Water Pipes Infrastructure) Regulations and the Sewerage and Drainage (Protection of Public Sewerage System) Regulations which will be introduced by PUB on 30 Jun 2017.

- 2. You will also know that we have met up with many of you to seek your feedback on the implementation of the said Regulations. We have taken in your feedback and made some changes. In one such case, for watermains < 300mm, we have reviewed and wish to inform you that there is no need to await PUB's response upon notification before commencement of work i.e. the contractor may proceed with the specified activity upon notification to PUB with supporting documents. For more information on the new Regulations, please refer to the website http://statutes.agc.gov.sg/.
- 3. Additionally, we are also working on developing a portal to ease the submission process. It should be ready by later this year. In the meantime, all your submissions relating to the new Public Utilities (Protection of Water Pipes Infrastructure) Regulations should be sent via email to PUB_WSN_Surveillance@pub.gov.sg for processing.
- We look forward to working with you towards a successful implementation as we work towards achieving zero damage on our watermains which serves good water 24/7 to customers like you and prevent the wastage of precious water. We also look forward to hearing from you. Please let us have your ideas and suggestions if any.
