(A) NEW ON-LINE CCTV VIDEOS & REPORTS SUBMISSION SYSTEM

(B) REVISED CORENET FORM APPLICATION FOR APPROVAL OF WORKS AFFECTING PUBLIC SEWER (WAPS)

We are pleased to inform you that, with effect from 1 Oct 2017, the CCTV sewer inspection videos and reports must be submitted by a registered CCTV contractor to PUB via the new online submission system at www.sewtv.sg. This new submission platform will bring about significant time and cost savings for the industry as we move towards a paper-free environment.

2 The pre-construction CCTV sewer inspection videos/reports shall be submitted only after the QP/PE has submitted the WAPS form via Corenet to PUB. The QP/PE shall provide the CCTV contractor the E-submission (ES/CR) number and a covering letter confirming that he has reviewed and accepted the pre-construction CCTV reports/videos. The CCTV contractor is required to submit the QP/PE's covering letter together with the CCTV sewer inspection videos/reports to PUB via the new online submission system.

3 Similarly, the post-construction CCTV sewer inspection videos/reports shall be submitted after the submission of Corenet form PUB-BPU-COMPOFWORK to PUB, as the E-submission number is required for submitting CCTV report. Please note that pre/post-construction CCTV report cannot be submitted without the E-submission number.

4 PUB has made changes to the form "Application for Approval of Works Affecting Public Sewers" (PUB-BPU-CLRDEV-OVERSEW) to include the latest sewerage protection requirements stipulated in the Sewerage and Drainage (Protection of Public Sewerage System) Regulations 2017 which came into effect on 30 Jun 2017. For more information on the sewerage protection requirements, you may refer to the PUB Circular dated 19 Sep 2017 or the revised advisory note which is available at https://www.pub.gov.sg/Documents/WRN_AdvisoryNotes.pdf.

5 Please synchronise your ESPro to use the latest form for your submissions from 1 Oct 17.
