CIRCULAR TO PROFESSIONAL INSTITUTIONS

Who should know
Developers, Architects, Engineers, Contractors and Builders

Dear Sir/Madam,

Expansion of the Lodgement Scheme (Landed Properties)

This circular is to inform all Qualified Persons (QPs) of an expansion to the Lodgement Scheme to include all landed properties, with the exception of strata title landed properties with communal facilities.

- 2 The current types of developments covered under the lodgement scheme are as follows:
 - a) Minor Development Projects (MDP) without pollution control (PC) and environmental health (EH) requirements (e.g. pavilions); and
 - b) Addition & Alteration (A&A) works to landed properties <u>without</u> any installation of airconditioning and mechanical ventilation (ACMV) systems
- In consultation with industry stakeholders such as the Singapore Institute of Architects (SIA), the Institute of Engineers Singapore (IES), the Association of Consulting Engineers Singapore (ACES) and the Singapore Contractor Association Ltd (SCAL), NEA will expand the lodgement scheme to include all landed properties, with the exception of strata title landed properties with communal facilities.
- 4 With effect from 1 Apr 2019, NEA will target to issue CSC clearances within 3 working days for landed properties (excluding strata title landed properties with communal facilities) that are able to comply with all environmental requirements (environmental health and pollution control). QPs can download a copy of the Lodgement Scheme Application Form (Landed Properties) from the following website:
