NOTIFICATION OF CHANGES TO THE BUILDING CONTROL REGULATIONS 2003

Objective

1. This circular notifies the industry of the changes to the Building Control Regulations 2003. These changes, as set out in the Building Control (Amendment) Regulations 2020, will come into effect on **10 February 2020**.
2. In summary, the changes are as follows:
 - (a) The list of insignificant building works under the First Schedule has been expanded. The details are shown in **Annex A**.
 - (b) The list of building works not requiring certificate of Accredited Checker under the Fourth Schedule has been expanded. The details are shown in **Annex B**.
