NOTIFICATION OF CHANGES TO THE BUILDING CONTROL REGULATIONS 2003

Objective

- 1. This circular notifies the industry of the changes to the Building Control Regulations 2003. These changes, as set out in the Building Control (Amendment) Regulations 2020, will come into effect on **10 February 2020**.
- 2. In summary, the changes are as follows:
 - (a) The list of insignificant building works under the First Schedule has been expanded. The details are shown in **Annex A.**
 - (b) The list of building works not requiring certificate of Accredited Checker under the Fourth Schedule has been expanded. The details are shown in **Annex B.**

First Schedule	1(g) any canal or drain not exceeding 1,500 millimetres in depth	 1(g) any canal or drain, including any associated earth retaining structure, if — (i) the depth of the canal or drain, as measured from the ground to the soffit of the base of the canal or drain, does not exceed 1,500 millimetres; or (ii) the following conditions are met: (A) the depth of the canal or drain, as measured from the ground to the soffit of the base of the canal or drain, exceeds 1,500 millimetres but does not exceed 2,500 millimetres; (B) the distance between each point of the canal or drain and any adjacent building or slope is at least 2 times the depth of the canal or drain as mentioned in sub-paragraph (A);



1(h) any box culvert with a span not exceeding 5,000 millimetres and a depth not exceeding 1,500 millimetres;	1(<i>h</i>) any box culvert with a span not exceeding 5,000 millimetres, including any associated earth retaining structure, if —
	(i) the depth of the box culvert, as measured from the ground to the soffit of the base of the box culvert, does not exceed 1,500 millimetres; or
	(ii) the following conditions are met:
